Digital award

Excellence in Patient Care Awards 2020: Digital award

Recognises and rewards the use of new or existing technologies or digitally driven projects that have contributed to significant improvements in patient care or health outcomes.

Winner: Flash Glucose Collaboration (ABCD, DTN-UK, NHS England) Supporting the uptake of innovative diabetes technology in the NHS



The project represents the alliance between the Association of British Clinical Diabetologists (ABCD), the Diabetes Technology Network UK and NHS England to improve access to flash glucose monitoring for people living with type 1 diabetes.

As diabetologists inspired by their clinical experience of life-changing flash glucose monitoring technology and the patient-led campaign by the charity Diabetes UK, this group of senior clinicians worked together to develop a strategy to ensure more widespread uptake of flash glucose monitoring. Through the provision of a national audit platform to demonstrate the benefits of the device, a national funding stream to address the postcode lottery in access and the development of online education resources for both healthcare professionals and people living with diabetes, the flash glucose collaboration have successfully supported the rollout of flash glucose monitoring to more than one-fifth of the type 1 diabetes population in England. The number of users more than doubled over a 7-month period and continues to grow, supported by the findings from national ABCD audit with data from over 10,000 users.

Recognises and rewards the innovative use of new or existing technologies and/or processes that have contributed to significant improvements in patient care or health outcomes.

Winner: Kettering General Hospital NHS Foundation Trust Ambulatory management of spontaneous pneumothorax



The Ambulatory Pneumothorax Service commenced in 2013 with just two consultants and slowly developed to the current team of three consultants (Dr RV Reddy, Dr M Naeem and Dr G Tsaknis) and two pleural nurse specialists.

Dr Raja V Reddy, MBBS FRCP, lead consultant respiratory physician, joined Kettering General Hospital NHS Foundation Trust in 2007 as the clinical lead for pleural diseases and lung cancer, and has an impressive portfolio in interventional respiratory medicine and innovation, with multiple publications, having developed the pneumothorax service and the 'day case' medical thoracoscopy service.

Dr Muhammad Naeem, MBBS MRCP, locum consultant respiratory physician, has had extensive training in lung and pleural interventions, and has been heavily involved in the lung cancer and pleural disease service since he joined the department 6 years ago.

Dr Georgios Tsaknis, MD PhD MRCP MRQA, consultant respiratory physician, has a strong research and interventional background, with many peer-reviewed publications. Together with Dr Reddy and Dr Naeem, they have expanded all interventional and ambulatory respiratory services in Kettering.

Samantha Rawson, lead pleural nurse specialist, joined Kettering in 2016 and quickly learned a variety of pleural procedures which she performs independently, including insertion of indwelling pleural catheters (IPCs) and chest drains.

Lesley Holland, pleural nurse specialist, is a key member of the team, expertly supporting the ambulatory pneumothorax service, as well as the rest of the patients with pleural disease. She was previously a lung cancer nurse specialist for more than 15 years in Kettering.

International award

Recognises and rewards projects that have been delivered outside the UK and have contributed to significant improvements in patient care and health outcomes in a particular country or region.

Winner: Team CAPD, Anuradhapura Teaching Hospital

Continuous ambulatory peritoneal dialysis (CAPD) saving lives in the north central province of Sri Lanka



Team CAPD has evolved since 2015 and consists of nephrologists, surgeons, hospital directors, medical officers, nursing officers, support staff, pharmacists, laboratory technicians, transport services, social workers, members of the Kidney Protection Foundation and CAPD patients. International and local experts contributed to the training of staff. With time, the team became a family of CAPD. Each member has contributed in a unique way.

Nephrologists were challenged with saving the lives of end-stage renal disease patients due to a limited number of haemodialysis slots in the north central province of Sri Lanka. Most patients were male paddy farmers who were the main earners in their family, with a poor socioeconomic and educational background. This initiative has revolutionised the quality of life for these socially deprived farming communities.

At this juncture, with the existing limited facilities and human resources, this programme was introduced and lead by the nephrologists. This was a strenuous learning process supported by the directors and the quality control unit.

Our doctors have meticulously assessed the suitability of patients for CAPD, a novel experience for the doctors and nursing staff as it involved individualised patient care. The Kidney Protection Foundation social worker transformed some of the existing housing facilities to suite CAPD through donations and public funds collected in tills kept at religious vicinities. This transformation process was further supported by the village heads, Buddhist monks and volunteers from the civil defence force.

At times it was necessary to insert a large number of CAPD catheters (15) in a single day with the support of surgeons and anaesthetists. This is the first time in Sri Lanka that transport officers organised free transport to the doorstep, through a partnership between the hospital and a charitable organisation.

Medical education and training award

Rewards projects involving the development of medical education and training programmes, services or structures that have improved the quality of patient care delivered, whether on a local or wider scale.

Winner: The Prescribing Safety Assessment (PSA) partnership



The PSA has been developed as a joint initiative by the British Pharmacological Society (BPS) and Medical Schools Council (MSC) to produce a national assessment of prescribing for all UK medical students.

The PSA is a 2-hour online assessment comprising eight sections which cover various aspects of prescribing defined within the outcomes for graduates identified by the UK General Medical Council. Students sit one of four PSA exams, which have been standard set using a modified Angoff process.

The PSA was implemented across all UK medical schools in 2014 following successful pilots. In 2019, a total of 7,820 final-year medical students in all 33 UK medical schools sat the PSA. The overall pass rate was 95.4%. In addition, a PSA pass is now required in order to complete foundation year 1. To date, around 50,000 graduating doctors have taken the PSA and used its practice materials.

The PSA has also grown internationally, providing derivative prescribing assessments in at least 10 other countries. The PSA is now the biggest dedicated prescribing assessment in the world.

Also, in 2019, an independent review of the PSA was carried out by Professor John McLachlan, the findings from which were complimentary. Recommendations arising from the review have been implemented as part of the drive to improve processes for 2020.

Winner: Moving Medicine, Faculty of Sport and Exercise Medicine (FSEM) UK



Moving Medicine is an initiative by the FSEM in partnership with Public Health England (PHE) and Sport England, led by a central leadership team of sport and exercise medicine consultants, a project manager, junior doctors and allied healthcare practitioners (AHPs). The FSEM provides governance and support to the central team. The initiative has been developed in partnership with PHE and Sport England. The primary aim of the initiative is to improve the quality and frequency of conversations on physical activity across healthcare and support the routine delivery of physical activity support for all.

The core leadership team includes Dr Catherine Lester, project lead; Dr Natasha Jones and Dr Hamish Reid, Moving Medicine clinical directors and founders; Dr Kush Joshi, paediatric resources lead; Dr Chris Speers, active hospital lead; Lacey Anning, Moving Medicine project manager; Tracy Barnett and Anna Lowe, AHP leads; Dr James Baldock, Moving Medicine sport and exercise medicine trainees lead; and Dr Zoe Chandler, undergraduates lead.

The real strength of the initiative comes from the remarkable contributions of over 400 healthcare professionals to developing clinically relevant, patient-centred content. This group has included nurses, doctors, pharmacists, psychologists, physiotherapists and researchers among others. They have led the development of 12 individual disease-specific modules in partnership with patient groups and key stakeholders in the charity sector.

Moving Medicine aims to increase physical activity through behaviour change and all members of the team have experience in physical activity promotion and exercise medicine.

Winner: FORWARD, Guy's and St Thomas' NHS Foundation Trust

FORWARD (feeding via the oral route with acknowledged risk of deterioration) – a novel tool to support patients eating and drinking at risk of aspiration

- > Alex Lang, lead dietician for stroke and elderly care, KCL lecturer, transformation programme manager at the Health Innovation Network in south London, and British Dietetic Association representative on the RCP Intercollegiate Stroke Working Party.
- > Naomi Soar, experienced SLT, with a strong interest in quality improvement, currently working as the FORWARD clinical specialist for this project.

Research award

Rewards original research that has contributed to, or has the potential to contribute to, significant improvements in health outcomes or the quality of patient care.

Winner: Newcastle University, South Tyneside and Sunderland NHS Foundation Trust and the Northern Region Endoscopy Group

Delivering world-leading endoscopy research across the UK



Newcastle University, South Tyneside and Sunderland NHS Foundation Trust and the Northern Region Endoscopy Group have developed a collaborative research network, led by Professor Colin Rees. The collaboration has subsequently extended across the UK transforming the way endoscopy research is delivered in the UK and internationally.

A collaboration of academia- and research-motivated endoscopy units have changed the landscape in endoscopy research by moving away from the historical model of limited single-centre studies to delivering collaborative multicentre studies, and in doing so, developed evidence-based practice within endoscopy. It has achieved this by evolution, initially recruiting to simple studies focused on service delivery and audit, then by training up a motivated network of researchers and research leaders, leading to development of high-quality novel trials addressing important clinical questions. This model has been extended to multiple sites throughout the UK.

Multicentre studies are now delivered using a streamlined approach including study development, peer review, collaborative grant applications and innovative patient and public involvement. The collaboration has led to delivery of the world's largest interventional endoscopy trials. Over 12,000 patients have been recruited with research addressing multiple priorities, including pathology detection and recognition, patient experience of endoscopy and identifying risk factors for colorectal pathology. The UK's standing for delivery of high-quality endoscopy research now makes it the first choice for the endoscopy industry.

The collaboration has now secured significant funding to establish a permanent formal infrastructure to deliver large scale endoscopy research nationwide – named COLO-SPEED (colorectal cancer screening, prevention, endoscopy and early diagnosis). This is currently delivering four studies, which will recruit 20,000 patients over the next 5 years. Multiple additional studies are funded or in development. The mantra is that all patients attending for endoscopy should have the opportunity to participate in research.

Consultant physician and geriatrician



in Patient Care Awards 2020: Contribution to the profession award

Dr Amit Arora is an internationally recognised consultant geriatrician at University Hospitals of North Midlands where he's been based since 2004. For years, he has not only led the change in the way care of older people is organised and delivered locally/regionally, but has also influenced national policy over the years.

He has been successfully blurring the boundaries between primary care, secondary care, social care, housing, voluntary agencies, patient organisations, charities and various provider trusts, and has led his team to over 15 national awards as winner or finalist.

Many services he developed are now commonplace nationally, but he has been an innovator or an early implementer in many such developments. These have included frailty front door services (2016+); multi-award-winning research programme (improving all high-level objectives (HLOs)); frailty fellowship (Master's course); silver helpline for patients (2015+); hotline for GPs (2015+) and intermediate care teams (2019); and many other new services.

He locally led the implementation of the NHS Long Term Plan 2019 and recently developed 'Staying well' clinics (one-stop multidisciplinary preventative frailty clinic). Working with the transformation delivery unit he has been instrumental in developing a 2-hour urgent community response team.

Working with charity Beat the Cold (2015+) and energy companies, he has helped develop an environmentally friendly social enterprise 'Saving-Lives-with-Solar' which provides free heating services to address fuel poverty.

He has served as chairman of the British Geriatrics Society England Council and chaired the 'Quality Review Standards' for frailty and dementia, available nationally. He serves on a number of advisory bodies for NHS England and the Department of Health and Social Care.

As a non-academic, he has over 100 publications including many book chapters, college reports (including the RCP and Royal College of Psychiatrists (RCPsych)), *Commentary* editorials, abstracts and articles. He is an examiner for MRCP-PACES and Diploma in Geriatric Medicine (DGM) exams of RCP.
