## for vice president for Wales (VPW) 2026–29

Nominations are invited for the office of VPW for 2026–29. Any three fellows who work in Wales may propose a fellow\* of at least 5 years' standing and who works in Wales for election as VPW. Members of the RCP Board of Trustees and senior officers must not nominate any candidate for election to this role. The elected candidate will work with the current clinical vice president, Dr Hilary Williams, to ensure smooth handover of duties, and will take up office as soon as possible following the election.

RCP Council will consider the nominations received together with the candidates' curriculum vitae to ensure that the candidates have the necessary experience or knowledge as required by the role description. Council will then nominate fellows for election as VPW. Council may choose not to include candidates whom it decides are not suitably qualified.

Nominees must have been fellows of the RCP for at least 5 years by the close of nominations.

Nominations must be received by the registrar by 5pm on Tuesday 6 January 2026, and the agreement of the nominee must have been obtained. An electronic copy of the nominee's curriculum vitae (template provided) should be included with the nomination. Nominees must also submit a declaration of interests (template provided) and a signed candidate contract by the nomination deadline.

<sup>\*</sup>A two-person job-share arrangement is possible for this role (and other elected vice presidents). This assumes that there is a joint nomination(s) and, if so, they would stand alongside any individual candidates. Any nominations made in this way would appear on the ballot paper on a joint ticket with a joint statement so that voters know they are standing on that basis (and so know they are voting for a package). The post is singular, even if two people were elected to do it.
