The next RCP President will inherit a great organisation in a time of great change. To meet the many challenges we face, the President needs to be engaging, experienced and energetic. I believe I have these qualities.

I envision an RCP that is listened to and respected by NHS leaders and politicians as the voice of our profession, by showing that we understand what support doctors on the ground need and by providing for those needs. I want an NHS that is true to its original values, with the workforce and capacity it needs; planned for long term, rather than in political cycles. I want an RCP that all members across the world are proud to be a part of, with sustainable high quality patient care as our core purpose.

The challenges we as physicians and the RCP face are:

- NHS workforce shortages combined with ever increasing demand for acute and specialty care
- Political uncertainty, austerity and a government distracted by Brexit
- A medical team demoralised by the junior doctor contract and loss of traditional structures
- Threats to specialty training from the demands of the acute take and an uncertain future with a new internal medicine curriculum
- Spiralling issues with obesity, alcohol and social inequalities
- Too often, poor local support for physicians in the workplace.

If elected I will put these challenges at the centre of what the RCP stands for. My priorities are:

- Our workforce pressing for a doubling of medical student numbers. Until that happens immigration policies that support the workforce and removal of the barriers which lead to early retirement
- Training ensuring training time is sufficient to provide high quality doctors in the specialties and a well-supported acute take, developing the MRCP so it remains the best clinical exam in the world and ensuring trainers and supervisors have the time they need
- Consultant working lives re-asserting consultant autonomy and professional identity, providing relevant and modern educational experiences and providing local support
- Public health clearly articulating the issues supported by legislation on obesity, alcohol and social inequality
- RCP policy establishing clear policy statements on the big issues so everyone knows 'what the RCP thinks'
- International development of 3 international offices to support overseas members with a voice on the world stage and improved working with representative organisations like BAPIO
- Clinical research making participation in clinical research easier and a seamless part of the NHS.

All candidates will share similar views, so why should you vote for me to lead the RCP?

- I'm (relatively) young. The RCP must be seen as a vibrant organisation that is relevant today and moving forward
- I understand the real pressures we face. Working in Derby I will continue to do acute take at weekends and overnight allowing me to 'tell it as it is' and showing the RCP is not just a building in London
- I can hit the ground running. As current RCP Registrar and former workforce lead I know the RCP 'warts and all' and have excellent working relationships with the staff, regional teams, medical specialties and arms-length bodies. I have regularly deputised for the President
- I am passionate about the RCP and the values it stands for. I firmly believe 'medicine is brilliant'. I helped write the 2018 RCP Charter which sums up what I think we are about as physicians. The RCP is in my core not just on my CV.

I believe we can thrive despite the challenges we face. To do so, though, we must be united as physicians whatever our specialty, career grade or workplace. Bound together we will be unbreakable.
