## for senior censor and vice president for education and training (VPET) 2026–29

Nominations are invited for the office of VPET for 2026–29. Any three fellows may propose a fellow\* of at least 5 years' standing for election as VPET. Members of the RCP Board of Trustees and senior officers must not nominate any candidate for election to this role. The elected candidate will work with the current president, Professor Mumtaz Patel, to ensure smooth handover of duties, and will take up office as soon as possible following the election.

RCP Council will consider the nominations received together with the candidates' curriculum vitae to ensure that the candidates have the necessary experience or knowledge as required by the role description. Council will then nominate fellows for election as VPET. Council may choose not to include candidates whom it decides are not suitably qualified.

Nominees must have been fellows of the RCP for at least 5 years by the close of nominations.

Nominations must be received by the registrar by 5pm on Tuesday 6 January 2026, and the agreement of the nominee must have been obtained. An electronic copy of the nominee's curriculum vitae (template provided) should be included with the nomination. Nominees must also submit a declaration of interests (template provided) and a signed candidate contract by the nomination deadline.
